**OLD BUSINESS** 

CFS Support for Music at Farmer's Market - Kurt

Many board members were in favor of allocating funds to help CAFM be able to continue offering music at the market. ACTION: up to \$500 in direct support of music. Kurt will communicate with Karen who will take it to the CAFM board.

## **NEW BUSINESS**

Low power community radio - Bill H

- Bill provided background on KORC, a low power community radio station start-up
- Located in downtown Corvallis; seeks to expand & air local music.
- Possible opportunity for CFS groups, individuals to perform on live radio
- Dave: KORC does have available time slots. He may get involved when he returns
- Jason curious: noted that more avenues exist now for getting content out: recording, posting, streaming, podcasts, Facebook live, etc.,

COVID Policy Discussion: Bill (See COVID Committee Report)

- CDC considers "low-risk" to be a rolling 7-day average of new cases of <10/100K population.</li>
- Consider one may have different standards for personal comfort vs. community safety
- Accommodations: Zoom: No restrictions needed, but must consider privacy issues,
  - e.g. focus of camera on caller & band, not on dancers
- Shell: hybrid model in CA. Providing access to disadvantaged communities.
- Zoom/live hybrid events pose more problems
- Note: Feelings of safety vary over time: like a dimmer, not an on/off switch
- Bill asked each board member about their personal comfort level:

Chere: maybe wait until New Year. Bill: protocols that require proof of vax reduce risk of severe disease. Van: require proof of vax; keep our community safe. Kurt: uncomfortable asking folks about vax status. Jason: ok with asking, but doesn't want to get shot. Dick: high-risk folks must be most conservative. Linda: unsettled by range of precautions seen in airports. Mark: very unsettled. Jason: OK dancing with FV persons. Shell: Ok outside and indoors with fully vaxed. Bill: Keep everyone safe; but remember value of doing things as a community. Anne: ok if meet at least 2 of 3 criteria outdoors, masked, distanced. Consensus: outdoors events ok

ACTIONS: COVID subcommittee to draft policy in August; send out

Jason still working on Community Survey

Request to all organizers to send Bill information related to COVID policy & venue restrictions.
