## REPORTS

- 1. Board Issues
  - a. Anne will continue as CFS Secretary until a replacement trainee can be IDd.
  - b. Co-president or vice president trainee Bill Hayden is interested
  - c. Outreach and volunteer organizing Shell do volunteer organizing in fall
  - d. Voting by electronic means: must mark email with VOTE in subject line
  - e. Technically part of secretary's job- to distribute and collect votes
  - f. Suggestions: have more than one "Annual" meeting per year to accommodate making changes in By-Laws and adding new board members
- 2. Treasurer Van See report
  - a. Van pursued MemberPlanet for back payment of membership dues
  - b. Lump sum payment inflated apparent income from dues: Total = \$2,842
  - c. Payments for ASCAP & Insurance seem higher because payment covered parts of 2-3 years
  - d. CDSS Affiliate status: we automatically enrolled when we buy insurance
  - e. CDSS Insurance: certificates of Insurance can be requested by any CFS member

  - b. Discussion: Who should get "free" newsletters?

  - b. Hoolyehs Covid policy put in the Newsletter following board approval
- 5. Concerts Chere See email report
  - a. John McCutcheon concert: CFS has no financial involvement in Whiteside concerts
  - b. Only concert request is Roy Zimmerman for November. Currently a "maybe"
- 6. Contra Dance Shell& Jason
  - b. three dances have been held all gone well
  - c. registration system working; folks are cancelling when they are sick
  - d. No Covid reported back by dancers
