CORVALLIS CELTIC FESTIVAL:

- "Save the Date" mini-flyers are out. CDSS News will run a 1/4 page ad in the June issue.
- CDSS approved a \$500 grant.
- Anne requested an updated budget report

The following groups discussed only Covid policy. Given that State, National (CDC), & even WHO are poised to end state of emergency, down-grading the pandemic

BEST CELLAR: Mark. Best Cellar requests dropping mask requirement; has already dropped vax checks

HOOLYEHS: Denis reported on recent party- 50 dancers, no masks and not aware of resulting Covid cases. Hoolyehs resume in-person dancing on May 8. Requests dropping mask & vax check requirements

CONTRA DANCE: Shell. Contra org. needs to discuss. Corvallis was following Portland policy, but Eugene voted 61% for no masks. Uniform policy across dance groups no longer exists; Shell wants to find out the process each group is using.

OLD BUSINESS

CFS General Covid policy: Discussion of need to revise.

CFS policy only requires the board to oversee/approve Covid policies created by individual activity groups for their own participants.

AGREED: No need to revise general CFS Covid policy.

CFS activity groups: Discussion of changes to individual group's Covid policies AGREED: Each activity group leader shall submit a revised policy to the board listing the precautions and safeguards currently felt to be adequate to protect participants. Because of short time line for approval, votes on new policies will be tallied via email
